# Information form to registered members regarding their personal data

## **THE NAUTICAL CLUB OF VOULIAGMENI (NOV)**

in accordance with the provisions of the General Data Protection Regulation (GDPR) 2016/679 (EU) of the European Parliament and of the Council of 27 April 2016, the provisions of the Greek Legislation, in the capacity of controller, informs the applicants on their registration as members in the NOV, of the following, in relation to their personal data.

## **LAWFUL BASIS OF COLLECTION AND PROCESSING OF PERSONAL DATA**

The NOV, under Article 6 of the Sports Law 2725/1999 and Article 17 of its Articles of Association, has the obligation to keep a Register of Members, in which the members registered in the Club are entered, as well as the personal data of the members.

## **SOURCE AND TYPE OF PERSONAL DATA**

The personal data of the applicants for registration in the Club are filled in and provided by the members in their application for registration. These data relate to information that can be used to identify members, such as: 1. Surname, 2. Name, 3. Father's name, 4. Mother's name, 5. Date of birth, 6. Place of birth, 7. Nationality, 8. Citizenship, 9. Residential address, 10. Profession, 11. Contact information etc.

In addition, NOV, for reasons of organization and communication, collects and processes user login and registration data, such as certified login details for electronic applications, as well as other information about its members, which they will provide as members of the Club, by filling out

forms or contacting NOV either by physical presence or by phone or e-mail or online or otherwise e.g. by proxy.

In addition, the Club, for communication purposes, collects and processes data-personal data of its members coming from records of correspondence and other communications with its members, including e-mail, live communication, direct messages and communications in social networking media. These data are collected and processed by NOV by manual and by automated means. Only the persons of the Management and Communication Department of the members and the Secretariat of the NOV have access to all the above personal data from the employees, and by the members of the Board of Directors authorized by it.

## **PURPOSE OF COLLECTION AND PROCESSING OF PERSONAL DATA**

The collection and processing of the personal data of the members is done for reasons of their registration in the Register of Members of the NOV, for reasons of promotion of the Club's purposes, for reasons of organization and communication with them for their information and support during the operation of the Club's services.

## **PERIOD OF RETENTION OF PERSONAL DATA**

The NOV shall retain the personal data of its members for a period of ten years from the date of loss of the status of that member, after which they will be destroyed, unless there is a need to extend that time, due to the existence of a legal claim or legal obligation of the Club.



## **TRANSFER OF PERSONAL DATA TO THIRD PARTIES**

NOV does not disclose or transfer to third parties the personal data of its members, unless

1. the members shall thereby give their express consent and
2. there are exceptional cases, imposed by a provision of law, a court decision, a prosecutor's order or due to a judicial investigation.

NOV, regardless of the existing lawful basis for the collection and processing of personal data of its members, requests from them and the provision of their consent for them.

## **RIGHTS OF MEMBERS AND HOW TO EXERCISE THEM**

Members have the right to request the following from the Club:

1. Access to their personal data as well as an electronic copy thereof.
2. Correction of their personal data if they are inaccurate or incomplete.
3. Restriction of the processing of their personal data, provided that their accuracy is questioned or provided for by applicable law or the purpose of the processing is missing and provided that there is no legitimate reason for their retention.
4. Objection or waiver of their consent for the processing of their personal data, as well as their deletion, if it is found that these are no longer necessary in relation to the reasons for which they were collected and subject to the obligations and legal rights of NOV for their retention on the basis of the applicable laws and regulations in force.

It is noted that the exercise by the member of his rights of the above no. 4 case may be a reason for not keeping it as a member in the Club. The above rights may be exercised by the members in the Club at the address Laimos Vouliagmenis 16671 Vouliagmeni, or at the email: [nov@nov.gr](mailto:nov@nov.gr). If they do not receive a reply within the prescribed period of one month and with - under conditions - an extension of two months or the reply they receive is unsatisfactory or, if their request is not resolved, they may contact the Personal Data Protection Authority ([www.dpa.gr](http://www.dpa.gr)).

The NOV requests the consent of the Members to send to their email or mailing address information / advertising material (newsletter). Their e-mail address will only be used by the NOV and will not be disclosed to third parties, even if the newsletter concerns products and / or services of third party companies cooperating with the NOV. The withdrawal of the members' consent to receive information / advertising material is possible, at any time, by selecting the link at the bottom of each newsletter sent to them by the NOV. In any case, the rights referred to above shall be recognized to the members.

The NOV, if the members so wish, will forward the data concerning your communication (email or mailing address) to third parties, who are members or sponsors of the NOV, to send to their email or mailing address information / advertising material (newsletter). The withdrawal of the members' consent to receive information / advertising material from the third sponsors or members of the NOV can be done by submitting a request for withdrawal of consent to the NOV, which will take care to inform the third parties, in order to stop sending them information / advertising material. Members shall also be able to withdraw their consent to any third party by selecting the link at the bottom of each newsletter sent to them. In any case, the rights referred to above shall be recognized to the members.

The NOV, in the context of achieving its objectives, organizes cultural, social, celebratory, entertainment and sports events. During these events, photographs may be taken and / or video footage of the events and of their participating members. The NOV requests the consent of the Members for their photographing, filming and recording in any other way during the above events, in which they may also participate for the use of their stored or recorded image, their name and their voice in a magazine published by the Club, in digital communication and social networking media and in the advertising spots on the occasion of its anniversary events. In any case, the rights referred to above shall be recognized to the members.
