

REGULATION OF V.N.C. OPERATION FOR MEMBERS - 2025

1. Parking at V.N.C.

- a. The parking area in front of the main entrance of V.N.C. and the "Armonia" parking lot are for the exclusive use of Club Members.
- b. Mopeds, bicycles and scooters should remain in the designated parking lot and are not allowed inside the facilities.
- c. Parking is only allowed for vehicles displaying the special Year 2025 parking sticker.
- d. The drivers should follow the instructions of the parking attendants.
- e. Entering the parking lot from the exit lane is strictly prohibited. Priority should always be given to vehicles leaving the parking lot.
- f. Circular traffic flow within the parking lot should remain unobstructed.
- g. Blocking the entrance to V.N.C. is strictly forbidden to ensure emergency vehicle easy access (ambulance, police, fire department, e.t.c.).
- h. In special cases, parking may be temporarily restricted.
- Compliance to these rules is mandatory for any Member using the V.N.C. parking facilities.
- j. Members who disagree with these terms may park their vehicles outside the Club's premises.

2. Entrance to V.N.C. Facilities

Only Members and their guests are allowed entry through the main entrance.

3. Accompanying Guests

- a. If a member is the sole registrant in his/her membership registry and is entitled to an Accompanying Guest, he/she may use up to 100 guest visits per annum. This number cannot be renewed.
- Accompanying Guests cannot be neither first- or second-degree relatives of the principal Member nor former (principal or dependent) Member of Vouliagmeni Nautical Club.

4. Members' Visitors

- a. Each family membership is entitled to:
 - i. 20 visits per annum, Monday to Friday, 06:00 a.m. 20:00 excluding public holidays
 - ii. 50 visits per annum, Monday to Sunday, 20:00 02:00 a.m. including public holidays
- b. The restriction on visits during weekends and holidays is due to high Member attendance, ensuring all Members are accommodated.
- c. The reception staff will assist in managing visitor entry.
- d. Visitors of Members who hold a yacht mooring at V.N.C. may enter solely for immediate yacht's departure. Each yacht owner is allowed 100 guest entries per annum. Prior e-mail notification is mandatory addressed to the Secretariat with guest full names and estimated departure/return time.
- e. Additional visits beyond the allocated quota cannot be granted.

5. Pets

Pets are not allowed on V.N.C. premises.

6. Delivery Services

- a. The use of third-party food and beverage delivery services is not allowed.
- b. Vouliagmeni Nautical Club operates a restaurant, lounge area and canteens at the Members' service.

c. Aligned to the Club's philosophy, supporting its catering partners is essential as they play a vital role in the Club's well-being.

7. Use of V.N.C. Equipment (chairs, sunbeds & shades)

- a. Sufficient seating and sunbeds are available with each Member entitled to one(1) seat or one (1) sunbed.
- b. Members should place for hygiene reasons their personal towel on chairs and sunbeds before use. Sitting on sunbeds in swimsuits without a towel is prohibited.
- c. Reserving seats with personal belongings is not allowed.
- d. Moving sunbeds under the dining area pergola of the South Beach is prohibited.

8. Cleanliness

- a. Every Member is individually responsible for maintaining the Club's cleanliness.
- b. Waste should be disposed in designated trash and recycling bins and used tables should be left clean.
- c. V.N.C. ensures regular disinfection of common areas (changing rooms, toilets, elevator, turnstiles, e.t.c.).
- d. Cigarette butts must be disposed in ashtrays.
- e. Writing or graffiti on the premises is prohibited.

9. Safety

- a. Minors should be at all times under their parents' supervision, not only for their safety both in the sea and on land but also for supervising them within the Club's premises. The Club hosts its athletes and members and during their presence they are kindly requested to respect everyone around.
- b. Members are responsible for their personal belongings. V.N.C. is not liable for any loss or damage. Lost items found by the cleaning staff are placed in a

designated lost-and-found box in front of the Secretariat and will be kept for one (1) week before being discarded.

- c. V.N.C. employees are not responsible for retrieving lost items.
- d. Any damage to the Club property should be reported to V.N.C. staff for immediate repair.
- e. The premises are monitored by a video surveillance system for the protection of individuals and property in accordance with Law 2472/1997.

10. Safe Swimming

- a. Swimming is permitted only within designated safe zones.
- b. Yachts, windsurf and/or SUP boards and other water vessels are prohibited in these areas.
- c. Fishing and spearfishing are not allowed.
- d. Lifeguard instructions should be always followed.

11. Water & Electricity Conservation

Members are encouraged to use water and electricity in a responsible manner. Always ensure that faucets are fully closed and lights in changing rooms/toilets are turned off when not in use.

12. Use of Showers

The use of shampoo or shower gel in outdoor showers is prohibited.

13. Cleaning of SUP Boards

Cleaning SUP boards with any detergent or soap is prohibited. Members are strongly advised to ensure that when their children wash their boards, there is no excessive use of water, and no disturbance is caused to those around them.

14. Noise Pollution

The use of personal audio devices or musical instruments is not allowed. Only background music approved by the Club is permitted and played at a low volume.

15. First Aid & Medical Assistance

In case of emergency, Members should contact the V.N.C. nurse at the on-site medical office. Lifeguards stationed at the Ski area and the South Beach towers are also equipped with First Aid supplies.

These regulations are in place to ensure a pleasant and safe experience for all Members. Compliance to all the above-mentioned regulations is mandatory.
